administrative remedies may deprive a court of jurisdiction to grant the requested relief. Horrell v. Dept. of Admin., 861 P.2d 1194, 1197 (Colo. 1993). However, there is an exception that a plaintiff need not exhaust potential administrative remedies if the administrative authority lacks the authority to rule on the question raised. Id.
